The second thing is that life is too short, so do one thing and do it well. Be the best carpet cleaner in your town. I was talking to Rodney Trent, an operator in Indiana, and he told me that when he first started, his largest competitor would wave at him in passing. Now he said his competitor won't wave or look at him. Rodney said he must be #1 in town now, because his competitor always holds up one finger to say hi. Why? Rodney has become the best in town.

The third thing is how you dress. It is one of the most important things you can do. He said "look like a marine in dress blues". Sometimes, looking good outweighs how comfortable we are.

Being the best in the industry takes a lot of effort and dedication. If we work at it a little at a time we can achieve greatness. Let's team up together to be the best we can be.
